INITIAL SECRET/FIRST INQUIRY REPORT

SUBJECT: Call up Notice u/s 19 of NAO, 1999 - Preliminary Inquiry into Mega Corruption of Local Government Department under auspices of the responsibles of Sindh Government.

Whereas this Bureau is conducting a subject inquiry against the accused persons mentioned below involved in mega corruption and corrupt practices, which is cognizable under section 9 (a), punishable under section 10 of National Accountability Ordinance, 1999 and 11 (c) schedule 4 of secret inquiry schedule thereto.

With reference to the subject matter this is to notify your good office that the Nab,s secret branch conducted a secret inquiry to reveal the mega corruption in the Sindh Local Government Board as well as the local government department all over the councils inSindh, for the last few months in which the secretary local government board Mr: Zameer Abbasi and the elected representatives of the ruling party were found direct and indirect involved, for a long time the corruption in this department could not be blinded, Elected representatives keep officers of their own choice in the councils and bring them to their will, there is no way to stop them or to keep a watch on them. The secret inquiry has revealed how zameer abbasi the former secretary Sindh local government board ran his office like a private company, the Nab secret branch has got a telephonic conversation recordings of MPA/MNA,s talking about the transactions of local councils. The officers who do not reduce accordingly to the wishes of the elected representatives are not given any posting as a result of which they also lose their salary.

Countless looting has been done in all local councils of Sindh which has also been pointed out some of them are elected representatives and some are their subordinates. Hence the institution of Nab is determined to bring all these co-criminals to justice and you are also required so that the money stolen from them can be deposited back into the national treasury.

In the preliminary secret investigation of Nab, the information regarding all the local councils of Sindh has been taken, in which the report has pointed out those, who were responsible for the transfer/postings of the Chief Executive Officers/Accounts Officer as well as Engineers.
